The National Council for Teacher Education (NCTE) invites applications for recognition of teacher training programmes for the academic session 2017-2018, except in the States and UTs, for the programmes, as specified in para 2 below. The applications in the prescribed format should be submitted "ONLINE" to the concerned Regional Committee alongwith the fee and requisite documents as prescribed in NCTE (Recognition, Norms & Procedure) Regulations 2014 upto 31ST May 2016.

2. The NCTE with a view to ensure planned and co-ordinated development of teacher education system and in order to regulate the growth of teacher education at all levels, has decided, on the basis of state-wise study conducted on 'Demand and Supply' of teachers and also in consultation with the State Governments / UTs, not to accept applications for recognition of teacher training institutions / programmes including additional intake / increase in seats in the existing recognised programmes, additional programmes for the academic session 2017-18 in the following States / UT (s) for the programme (s) specified against each.

4. The above restriction shall, however, not apply in cases of Central Universities and Universities / Institutions established and fully funded by the Central/ State Government, but shall apply if the programmes are offered on self-financing basis.

5. The above restriction will not apply in case of Minority institutions established under Article 30 of the Constitution

6. This step of banning certain programmes as stipulated under para 2 above, is being taken by NCTE for the Academic Session 2017-18 only.

RECOGNITION ORDER

WHEREAS in terms of section 14(1)/15(1) of the NCTE Act, 1993, the institutions had submitted applications to the Northern Regional Committee of NCTE for grant of recognition for Teacher Education Courses.

2. AND WHEREAS on scrutiny/perusal, veracity of the facts & figures as per the application submitted by these institutions, the documents attached therewith, the affidavit and the input received from the visiting team in the form of visiting team report including videography and also the reply submitted by the institution against letter of intent under clause 7(13) of the NCTE Regulations, 2014 (earlier 7(9) of the NCTE Regulations, 2009), the Northern Regional Committee in its **236th Meeting of the NRC held on 29-30 April and 1-2 May, 2015** is satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the concerned Teacher Education Programme such as instructional facilities, infrastructural facilities, library, accommodation, financial resources, laboratory, etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

3. NOW, THEREFORE, in exercise of the powers vested under Section 14(3)(a)/15(3)(a) of the NCTE Act, 1993, the Northern Regional Committee hereby grants recognition to the following Institutions for conducting Teacher Education Course with an annual intake mentioned against their names from the academic session **2015-2016** under clause 7(16) of NCTE (Recognition Norms & Procedure) Regulations, 2014 subject to fulfilment of the conditions mentioned below :-

- The institution shall comply with various other norms and standards prescribed in the NCTE regulations, as amended from time to time. The Institution shall fulfill the revised Norms relating to infrastructure, instructional facilities, enhanced amount of Endowment and Reserve Fund, Number and qualifications of Teaching Staff, Curriculum and implementation strategies in view of the change in duration/intake of programme(s) offered in the institution within the time limit allowed by NCTE.
- The institution shall make admission only after it obtains affiliation from the examining body in terms of clause 8(10) of the NCTE (Recognition Norms & Procedure) Regulations, 2014.

D in Education]

(D) Visual and Performing Arts

- (i) Masters degree in Fine Arts/ Music/ Dance/ Theatre with 50% marks.

Note : In a composite institution, the Principal and academic, administrative and technical staff can be shared. There shall be one Principal, and others may be termed as HoDs.

5.4 Terms and Conditions of Service

The terms and conditions of service of teaching and non-teaching staff including selection procedure, pay scales, age of superannuation and other benefits shall be as per the policy of the State Government/Affiliating body.

The institutions shall adhere to the fulfillment of the provisions of the NCTE Regulations, 2014 and ensure the following before commencement of the session:-

- (a) The institution which have submitted reply to Letter of Intent and appointed staff as per provisions of the NCTE Regulations, 2009 with the approval of the affiliating body shall be required to modify/replace the required faculty as per provisions of the NCTE Regulations, 2014. The institution shall be required to submit the compliance report before the commencement of the session 2015-16.

- (b) As per the provisions of the NCTE Regulations, 2014 an institution is allowed/permitted to take two units at a time of a teacher education programme. Accordingly, the faculty requirements have been laid down for two units of the programme in the Regulations 2014 i.e. for 200 students in the first and the second year. However, those institutions whose applications are pending if opt for one unit i.e. 100 students in the first and second year, the requirement of faculty shall be reduced to eight out of which five lecturers i.e. one each for Science, Social Studies, Mathematics and two for Languages and one Health and Physical Education lecturer and one Performing/Visual Art Lecturer, and one Principal or Head of the Department shall be appointed. One of the lecturers may possess post graduation degree in Psychology/Philosophy/Sociology if the Principal/Head of the Department possesses PG degree in one of the school subjects.
- (c) The institutions having applied for D.El.Ed. course are being granted recognition for one unit only, as the application made by the institution was for an intake of 50 students.
- (i) The institutions whose applications were pending with the Regional offices before 1.12.2014 (the date of notification of Regulations, 2014), shall be considered for recognition as standalone institutions but they shall move gradually to become a composite institution but not later than 2016-17.
- (ii) As per the guidelines issued by the NCTE Hq vide letter No. 51-4/2014/NCTE/N&S dated 24th December, 2014 the institutions shall be required to fulfill the requirement of additional staff, infrastructure by 31st October, 2015 in case recognition has been granted for two units of B.Ed. course. However in respect of B.Ed. programme, under new Regulations, 2014, there is a change in basic unit size and required infrastructure, staff pattern etc., the NRC shall cause inspection of the institution by 29 Feb., 2016 for ascertaining the fulfillment of infrastructure facilities. If the institution fails to comply with these requirements, the permission given for one basic unit out of two basic units shall be withdrawn.

4. Further, the recognition is subject to fulfilment of all such other requirements as may be prescribed by other regulatory bodies like UGC, affiliating University/ Body, the State Government etc. as applicable. The affiliating body (University/State Govt.) shall also required to verify the authenticity of the land & building documents as well as appointment of requisite teaching & non-teaching staff as per provisions of the NCTE Regulations, 2014 by the concerned institution before grant of affiliation to an institution.

5. The institution shall submit to the Regional Committee a Self-Appraisal Report at the end of each academic year along the statement of annual accounts duly audited by a Chartered Accountant.


6. The institution shall maintain & update its Web-site as per provisions of NCTE Regulations and always display following as mandatory disclosure:-

- (i) Copy of the Application Form
- (ii) Land and Building Particulars
- (iii) Staff Profile
- (iv) Recognition letter
- (v) Information for having fulfilled the norms & standard and other required conditions.

7. In case if the land is in the name of the Society/trust, the land is to be transferred within six months in the name of the institution, failing which action shall be initiated to withdraw the recognition. It shall be essential on the part of the institution concerned to get the needful done in this regard and intimate about the same to the respective Regional Committee along with the new land documents within the stipulated time.

8. If the institution contravenes any of the above conditions or the provisions of the NCTE Act, Rules, Regulations and Orders made or issued there under, the Regional Committee shall withdraw the recognition as under the provisions of Section 17(1) of the NCTE Act.

9. Further, if the institution is not satisfied with the order, it may prefer an appeal under sections 18 of NCTE Act, 1993 in the "online mode" available on NCTE's website www.ncte.india.org within 60 days from the date of this order. The guidelines for filing appeal may be seen on NCTE's website.

Sir/Madam,

In terms of section 14/15 of the NCE Act, 1993, your Institution had submitted an application to the Northern Regional Committee of NCTE for grant of recognition/permission for starting D.El.Ed. Course in the proposed institution i.e. **Shambhunath College of Education, Plot No.-89,90,91, Village – Rahimabad, Post Office – Peepalgaon, Tehsil– Sadar, Dist.– Allahabad, State– Uttar Pradesh – 211012.**

2. The NRC, NCTE on the basis of the scrutiny of the documents submitted by the institution, input received from the Visiting Team Report and videography in its **232nd Meeting (1st Sitting) held on February 2nd – 6th, 2015** observed that the above institution has adequate financial resources, accommodation, library and laboratory as prescribed in the norms and standards and that it fulfils all such other conditions relating to infrastructural and instructional facilities required for proper functioning of the institution for a teacher education course and decided to issue Letter of Intent under clause 7(13) of the NCTE Regulations, 2014.

3. As per provision of clause 7(13) of the NCTE Regulations, 2014, the process of appointment of qualified staff as per policy of State Government or University Grant Commission or University may be initiated by the institution and affiliating body will provide all assistance to the institution to ensure that the staff or faculty is appointed as per National Council for Teacher Education norms within two months. The institution shall submit the list of faculty, as approved by the affiliating body, to the Regional Committee.

4. In this regard as per decision taken by NRC in its 199th meeting, it is clarified that the above implies that where there exists a provision of nomination of expert/experts for the Selection Committee by the affiliating university, the same be adhered to. In the absence of such a provision in the Act/Statutes of the affiliating university, the institution shall select faculty members by employing a transparent, objective and judicious process and shall get the list of selected teachers approved by the affiliating university. This approved list, along with details of educational qualifications and teaching experience, shall be submitted by the institution to the Regional Committee.

5. In view of above, before grant of formal recognition under Regulation 7(16) of the NCTE Regulations, 2014 is considered, the following documents are required to be submitted by the institution:-

- The institution shall submit particulars of the staff duly approved by the University/affiliating body as per prescribed format available on the NRC, NCTE website.
- Advertisement given for recruitment of faculty and staff.



- c. Recommendations of the Selection Committee for appointment of teaching & non-teaching staff as per the norms of the affiliating body.
- d. An affidavit on Rs. 100/-stamp paper to the effect that the institution has selected staff as per NCTE/State/University norms. (Format Enclosed).
- e. An affidavit on Rs. 10/-stamp paper from each of the faculty members to the effect that he/she is qualified as per provisions of the NCTE/State/University norms. (Format enclosed).
- f. Educational & professional qualification certificates of all teaching staff showing their eligibility for appointment as per the NCTE norms and experience certificate of the Principal /HOD.
- g. Downloaded copies of the website of the institution with the hyperlink of the same as per provisions of clause 7(14) of the NCTE Regulations, 2014.
- h. The institution shall convert the Endowment Fund & Reserve Fund into a Joint Account and furnish the evidence / documents in this regard to NRC alongwith Form "A" showing the details of the FDR Account No., Name of the Bank and address, Phone No. of the Bank, Branch Code, IFSC Code, and Signature ID Code of the issuing authority of the FDR. An authorization letter from the Regional Director, NRC, NCTE authorizing the institution to convert the FDR into joint account is enclosed. In respect of B.Ed. programme, under new Regulations, 2014, there is a change in the basic unit size and required infrastructure, staff pattern, etc. If pending applicant institutions seek Formal Recognition for two basic units, the following conditions will apply as per the above guidelines:
 - (a) The institutions willing to offer two basic units can be given Formal Recognition before 3rd March, 2015. However, the institution shall create additional built-up area, create additional infrastructure, adhere to staff norms, qualifications of staff, pay the difference in Endowment and Reserve Fund etc by October 31, 2015 and inform the Regional Committee with necessary documents.
 - (b) The institution must comply with staff requirement and Endowment and Reserve Funds as per the new Regulations for one basic unit before issue of final recognition order.
 - (c) The Regional Committee shall arrange for inspection of these premises, verification of documents and check adherence to these conditions by 29th

February, 2016. If the institution fails to comply to these requirements, the permission given for one basic unit out of two basic units shall be withdrawn.

- j. It shall be noted by the institution that apart from the above, if any additional infrastructure/instructional facility is required as per provisions of the NCTE Regulations, 2014, the same shall be complied and reported by the concerned institution to the Regional Committee.

The above documents should be accompanied with written representation alongwith an Affidavit (on Rs.100/- stamp paper) stating under oath for correctness of documents being submitted by the institution to NRC, NCTE.

6. You are advised to comply to the above requirements before the case for formal recognition is considered under clause 7(16) of the NCTE Regulations, 2014.
7. Admissions shall not be made until formal recognition under clause 7 (16) of the NCTE Regulations, 2014 is issued by the Northern Regional Committee, NCTE and affiliation is obtained from the University/examining body concerned.
8. The compliance report/reply alongwith all necessary documents accompanied with an Affidavit in support of the reply on the above points should be submitted **within two months of issue of this letter, failing which appropriate action will be taken as deemed fit and proper.**

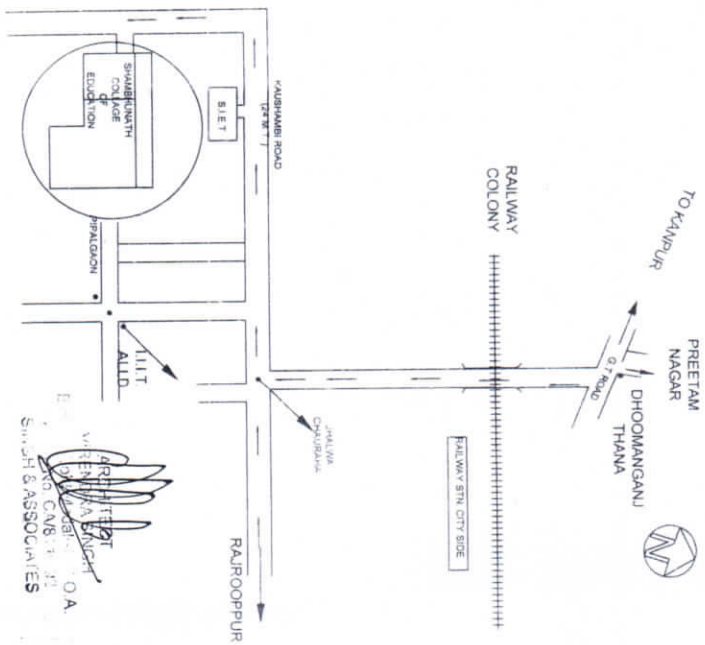
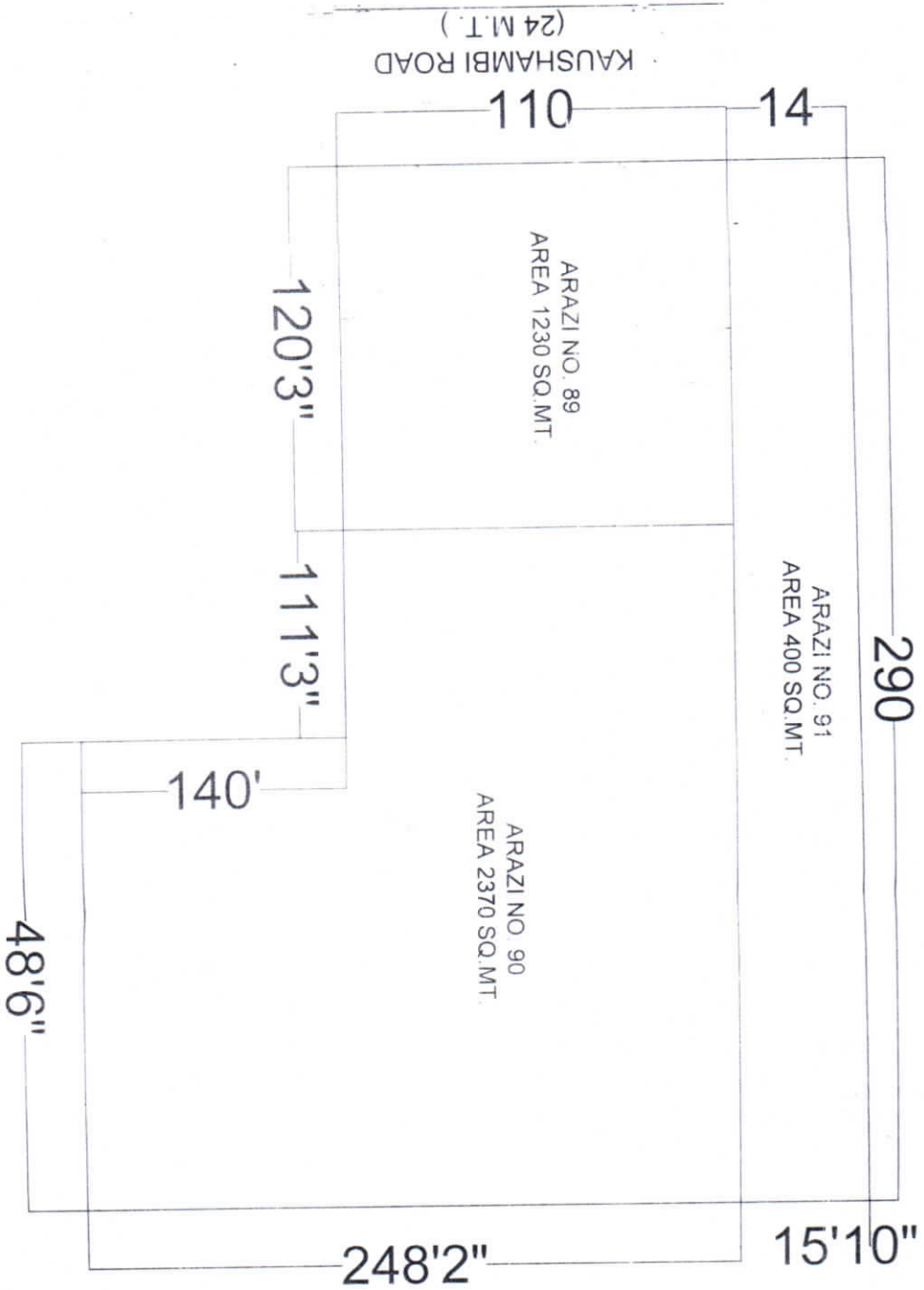
KEY & SITE PLAN OF SHAMBHUNATH

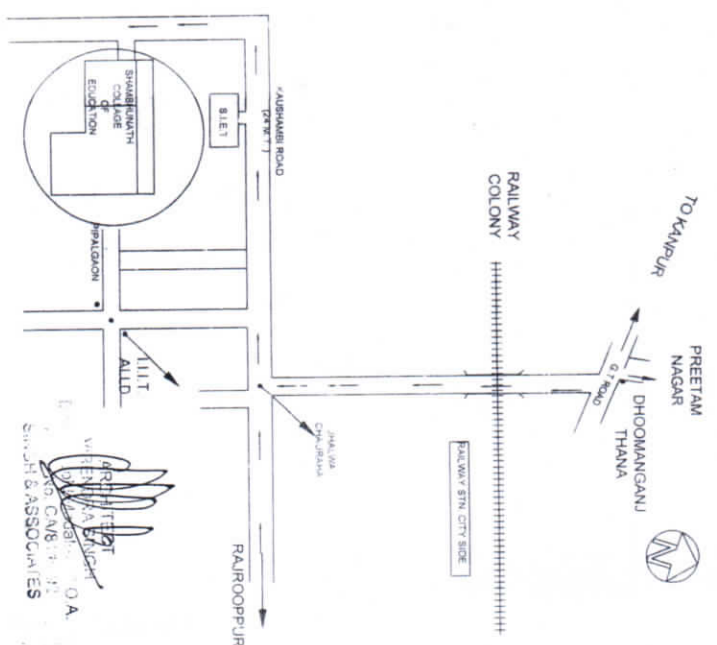
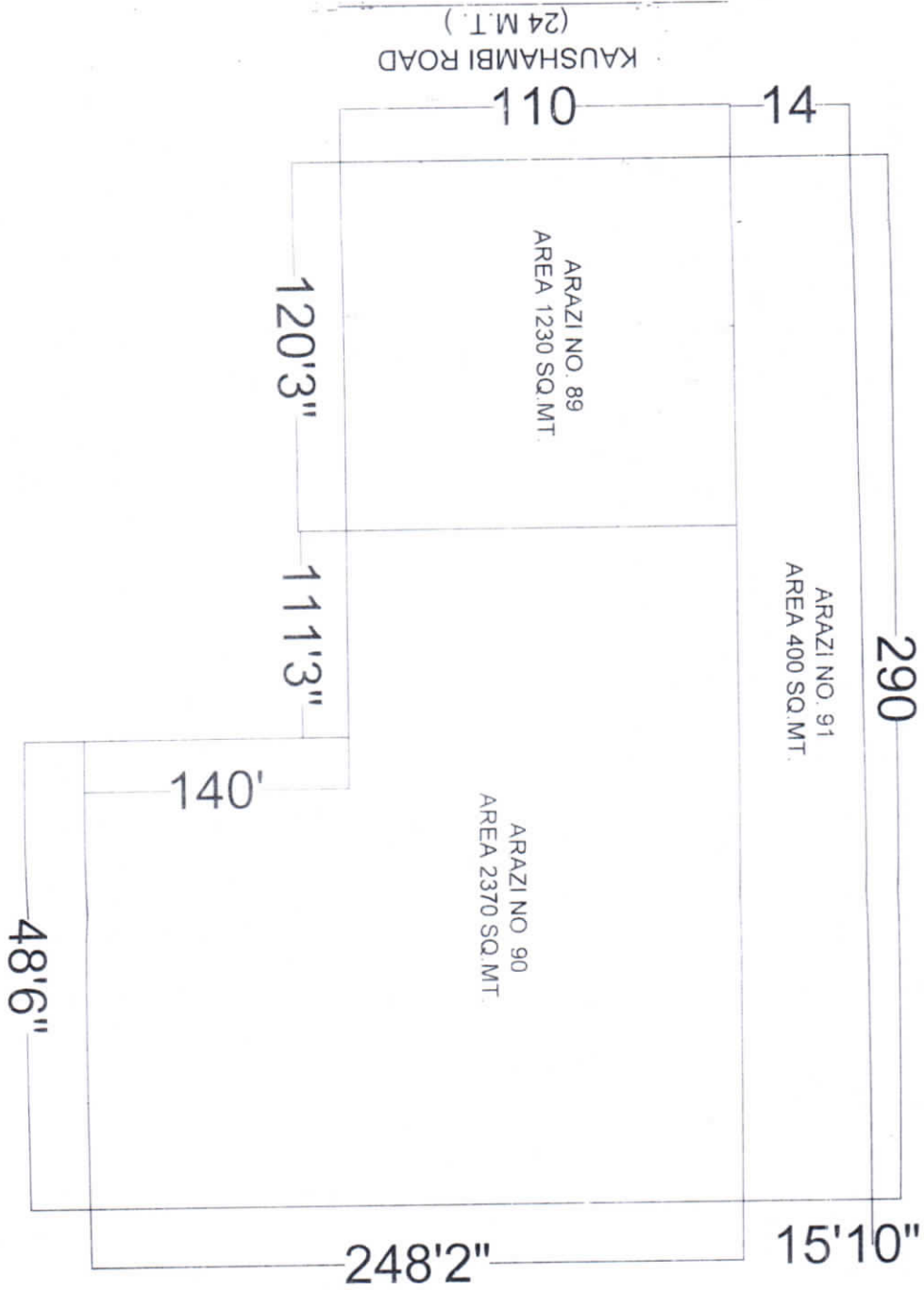


KEY & SITE PLAN OF SHAMBHUNATH COLLEGE OF EDUCATION(D.E.Ed.)

Note:- Before taking further action for inspection, the VT Members & Representatives of the above Institutions are requested to read the following instructions carefully.

- As you are aware, that the NCTE is a statutory body which was established under the NCTE Act, 1993 for coordinated development of the teacher education in India. The Visiting Team has a very important role to play in deciding the case of the institution which submits the application for grant of recognition to the NCTE. The statutory directions are to be followed by the Visiting Team Members and as per direction of the Northern Regional Committee, NCTE, I would request you to kindly visit the above institution as an expert member of the team so as to scrutinize & verify the infrastructural & instructional facilities created by the institution with a view to assess the level of preparedness of the institution and also to verify the infrastructural & instructional facilities as per the NCTE norms and standards to commence the course.
- The VT shall prepare its own work schedule for the examination of documents, physical verification of facilities and interaction with different stakeholders. The Report shall also include the filled-up proforma submitted by the institution and fresh documents made available by it, if any. It should be ensured that each page of the filled in proforma as per provisions of clause 7(4) of the NCTE Regulations, 2009 is signed by the Head of the institution or an authorized representative of the Management of the institution, clearly mentioning the name and designation. The V.T. after receipt of the requisite original/authentic documents as per the application submitted by the institution alongwith other relevant documents as per proforma under clause 7(4) of the NCTE Regulations, 2009 from the institution, the inspection team is required to scrutinize, verify and assess the availability of infrastructural and institutional facilities and availability of the requisite staff (in case the same is appointed by the institution) as prescribed by the NCTE in its Norms and Standards for the programme as per provisions of the NCTE Act, Rules & Regulations. It may be noted by the Visiting Team that all the latest norms & standards including NCTE Act, Rules & Regulations' as amended from time to time are available on the NCTE website, namely, www.ncte-india.org. The guidelines for filling up the VT proforma are enclosed with the VT proforma.
- Inspection of the above institutions will be conducted between **24.02.2014 to 10.03.2014** VT members are requested to consult each other telephonically and by mutual understanding fix the date for inspection of the institutions under intimation to the NRC, NCTE. A written intimation regarding the date of inspection may be faxed/e-mailed to this office shortly before moving for inspection.
- It shall be taken into note by the above institutions that it is the responsibility of the institutions to ensure presentation of the original/correct/authentic figures & facts of the application, land & building documents, infrastructure & instructional facilities to the Visiting Team. The same shall be as per the requirement of the NCTE Act, Rules & Regulations. There shall not be any wrong information or concealment of facts in the application which may have bearing on the decision making process or the decision pertaining to grant of recognition.
- It shall also be noted by the above institutions that as per provision of Clause 8(7) (i) "no institution shall be granted recognition under NCTE Regulations, 2009 unless the institution or society sponsoring the institution is in possession of required land on the date of application. The land free from all encumbrances could be either on ownership basis or on lease from Government or Government institutions for a period of not less than 30 years." Also as per clause 8(7) (ii) "the society sponsoring the institution shall have to ensure that proposed teacher education institution has a well demarcated land area as specified by the norms. The teacher education institution shall not be allowed to have any other institution within its demarcated area or building and shall not have any other course (s) in its building."
- As per clause 7 (1-B) of the NCTE Regulation, 2009 "furnishing any wrong information or concealment of facts in the application, which may have bearing on the decision making process or the decision pertaining to grant of recognition shall result in withdrawal of recognition of the institution besides other legal action against its management." A copy of NCTE Act, Rules & Regulations and norms & Standards thereof are also available on the NCTE website www.ncte-india.org and also on the NRC website www.nrcncte.org.
- As per provision of Clause 7(5) of NCTE Regulations, 2009, at the time of visit of the team of experts to an institution, the institution concerned shall arrange for the inspection to be videographed in a manner that all important infrastructural and instructional facilities are videographed alongwith interaction with the management and the faculty, if available at the time of such visit. The visiting teams, as far as possible, shall finalise and courier their reports alongwith the video tapes on the same day.

Provided that the videography should clearly establish the outer view of the building, its surroundings, access road and important infrastructure including classrooms, labs, resource rooms, multipurpose hall, library etc. The visiting team shall ensure that the videography is done in a continuous manner, the final unedited copy of the videography is handed over to them immediately after its recording and its conversion to a CD should be done in the presence of visiting team members:-

Provided further that at the time of inspection for new courses or enhancement of intake of the existing course, the visiting team shall verify the facilities for existing teacher education courses accorded recognition by National Council for Teacher Education and would ascertain the fulfilment and maintenance of Regulations and Norms and Standards for the existing courses as well.

8. The VT Proforma and NCTE Regulations dated August 31, 2009 with relevant norms and standards are handed over to **Dr. D.S. Chauhan** for necessary action as per provisions under Section 14/15 of the NCTE Act, 1993. A copy of the NCTE Act, Rules & latest Regulations and norms & Standards are also available on the NCTE website www.ncte-india.org and also on the NRC website www.nrcncte.org.

9. The Visiting Teams shall finalize their reports along with the VCD/CD on the same day and the same shall be dispatched to the Regional Director, NRC, NCTE on the same day failing which the responsibility shall be of VT only. In addition to all important documents, the VT shall be required to obtain the following documents from the Management of the institution as per the applicability of the provisions of the NCTE Act, Rules & Regulations:-

- Building completion certificate
- A duly filled in proforma as per provisions of 7(4) of the NCTE Regulations, 2009
- Particulars of staff

The required formats of the above certificates/ proformas are available on the NRC, NCTE website www.nrcncte.org.

10. In view of the above, the V.T is required to submit the report (No column of the report proforma should be left blank and columns not applicable should clearly be indicated and struck off and further each page to be duly signed by both members) addressing to the Regional Director, NRC, NCTE in order to place the same before the NRC for suitable decision as per provisions of the NCTE Act, Rules & Regulations in a sealed cover on the same day on completion of inspection.

11. TA/DA/Honorarium and other expenses related to your stay shall be paid by NRC, NCTE as per rules (copy enclosed). As such, the inspection team members should not accept any gift, hospitality, TA/DA etc. offered by the Institution. Any violation of this instruction would not only debar the inspection team member from undertaking any inspection further on behalf of NRC/NCTE and other action would also be initiated against the visiting team members as per law.

12. The members of the Visiting Team (VT) are requested to enclose a photocopy of this letter alongwith their TA/DA bills duly signed to facilitate payment in time.
