Note : The Uttar Pradesh Technical University, Lucknow was established by the Government of UP on 8th May, 2000 vide Act No. 1248(2)XVI-V-1-1(k)-19-2000. On 15th February, 2010, Uttar Pradesh Technical University, Lucknow was renamed as Gautam Buddha Technical University, Lucknow and a new University was created namely Mahamaya Technical University, Noida, vide Notification No. 236(2)XXIX-V-1-10-1(k)-6-2010. On 31st October, 2013, Gautam Buddha Technical University, Lucknow and Mahamaya Technical University, Noida were merged to form Uttar Pradesh Technical University Lucknow vide Notification No. 3324/16-1-2013-1(3)/2009. Government of UP, vide Notification No. 1156(2)LXXIX-V-1-15-1(k)-24-2015 dated 9th September, 2015, renamed Uttar Pradesh Technical University, Lucknow as Dr. A.P.J. Abdul Kalam Technical University, Uttar Pradesh, Lucknow.
