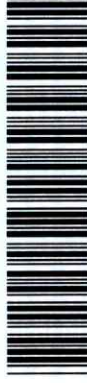

Note : The Uttar Pradesh Technical University, Lucknow was established by the Government of UP on 8th May, 2000 vide Act No. 1246(2)XVII-V-1-(ka)-19-2000. On 16th February, 2010, Uttar Pradesh Technical University, Lucknow was renamed as Gautam Buddha Technical University, Lucknow and a new University was created namely Mahamaya Technical University, Noida vide Notification No. 236(2)LXIX-V-1-10-(ka)-6-2010. On 31st October, 2013, Gautam Buddha Technical University, Lucknow and Mahamaya Technical University, Noida were merged to form Uttar Pradesh Technical University Lucknow vide Notification No. 3324/16-1-2013-1(3)/2009.
