



In the case of other categories of persons with benchmark disability, the provision of a scribe can be allowed on production of a certificate from the Chief Medical Officer/Civil Surgeon/Medical Superintendent of a Government Health Care Institution, to the effect that the person concerned has physical limitation to write, and scribe is essential to write the examination on his/her behalf. The PwBD Candidate can bring his/her own scribe or may avail the same from the examining body. #All the candidates with benchmark disability not availing the facility of scribe will be allowed compensatory/extra time of 20 minutes per hour of the examination.</p>


