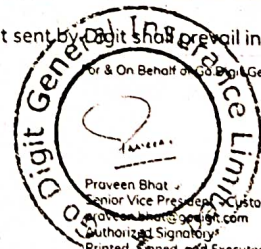

**Cheque dishonor / Non-receipt of payment:** premium paid through Cheque, the policy is void ab-initio in case of dishonor of Cheque or non-receipt of payment.

**Violation of Motor Vehicle Act:** This policy is issued in accordance with the provision of Chapter X and Chapter XI of MV act, 1988 and any subsequent amendment as applicable.
